Chief Freis,

I am writing to clarify that my demand for your resignation yesterday was not a reactionary statement. It was a conclusion based on a mountain of evidence that I have spent the last 24 hours codifying. The more I look into your administration, the more I realize that the rot is not just financial—it is moral.

**The Failure of Public Safety** Last year, I was robbed at gunpoint. I hesitated to report it because the reputation of your department preceded you: I knew you would do nothing. When I finally provided your officers with the suspect's **name, address, and phone number**, my intuition was proven correct. You did nothing. In the last year, I have been assaulted at the dog park three times. Each time I screamed for help, no one called the police—not because they didn't care about me, but because the citizens of Addison know in their hearts what I now have in writing: **You are not coming to help.**

**The "Donut Shop" Standard** The logs your own department turned over provide the "Signal" within the "Noise." They show a department that has completely abandoned its post. To wit: your officers remained at a donut shop for 40 minutes after a call came in. When they finally decided to move, the responding officer hit a Chick-fil-A drive-thru before attending to the citizen in need.

**The Revenue Machine vs. The Citizen** I now understand why my case was ignored. There was no "collection fee" attached to my robbery. My assault didn't trigger a 30% bounty for a private law firm.

I have spent today linking the following evidence:

- **Ordinance O24-021 & The Linebarger Contract:** You have codified a 30% "tax" on the poor and the targeted while your department ignores violent crime.
- **The Warrant Factory:** Your bi-weekly "Warrant Runs" (FY23-FY26) show a court system that operates with mechanical precision only when it involves extraction.
- **The Liquidation of Assets:** Under the supervision of City Manager David Gaines, you are selling off high-value city assets (like 2020 Tahoes and F-350s) for pennies on the dollar—effectively bleeding the public treasury dry while claiming you "don't know" where \$190 million went.
